# New Online Training Site

Our catalog is now composed of 60 hours of free online training!

You can now take the following courses for free.



We launched our new online training site with Nuvola Academy on May 16, 2016. We transitioned to the new site with zero downtime and a limited catalog. The Rules Overview courses were the first courses on the site since they are required for the state examination. We immediately began re-working the courses from our previous site to perform properly on our new site, releasing a few courses a week. Within four weeks all of our courses were up and running on the new site, as well as a few new ones. Our newest course, The State and Federal Law Update—3184, donated by The Texas Department of Public Safety, has been our most popular one with over 600 student completions its first month online.

We hope students find our updated cleaner-look easier to navigate. Course progress bars on each course help you determine how far you've come in the course and how close you are to finishing. The new course dashboard shows the number of students enrolled in the course and the average rating volunteered by fellow students, as well as a course description, instructions, and access to the course modules and exam. The

new student dashboard displays information about each course the student is enrolled in and a listing of certificates for courses completed on this site. Getting in contact with and leaving feedback for TCOLE is easier than ever with links offered throughout the site.

# Service Time – How Does TCOLE Arrive At My Total? By Jessica Teseny

Are you evaluating your service time, trying to figure out when you'll qualify for your next proficiency certificate? There is actually a really easy way to find out how many years of full time service you have, but you may be wondering how TCOLE arrived at that total.

Keep in mind that your *service time* and the *number of years you've held a license* are different things. The proficiency certificates are looking for active years of service-that is, the years you have served actively working for a department in that specific license type.

Say you're an officer that was issued a license 20 years ago. You worked for a department for 12 of the 20 years. In this case, your service time is 12 years. Although you received your license 20 years ago, the time you spent actively working within that license was 12 years. So, when we look at your service time to see if you qualify for the master certificate, we will only take the 12 years into consideration.

Another point to consider when calculating your service time is whether or not you had overlapping service or dual appointments. Service time that runs concurrent with another service for a different department, but for the same license type, is only counted once.

This happens when an officer works a dual appointment, or at two or more departments at the same time. For example, Department A held your commission on reserve status for 2 years. During that time, you worked for Department B part-time for 1 year. When you look at your record, you see both departments listed in your service history with their own start and end dates. At first glance, it looks like that should total up to 3 years. But, since 1 of those years overlapped another, you're actually looking at 2 years of service.

The next thing to consider is that service time is not cumulative across all license types; service associated with each license is counted separately. Peace Officers, Jailers, and Telecommunicators each have different requirements for their respective proficiency ladder. Someone holding more than one license type must follow more than one set of requirements to advance in proficiency.

So, a peace officer who also holds a jailer license cannot add their 4 years of jailer service to their 2 years of peace officer service to make 6 total years. The 4 years of jailer service is counted separately from the 2 years of peace officer time. To the same extent, qualifying for the advanced jailer

proficiency with 4 years of jailer service will not also qualify you for the advanced peace officer if you do not meet the requirements on the advanced peace officer certificate chart.

What's the easiest way to find out how much service time you have? Just log into your MyTCOLE account, and go to the My Records > Appointment Time tab. Each license you hold will be listed with the total years of service calculated for you.

## Where's my Instructor Certificate?

If you want to be officially recognized by TCOLE as an instructor, you have to submit the Instructor Proficiency Certificate Application after you've completed the Basic Instructor Course (1014). The application step is often forgotten and people contact us wondering where their certificate is. Although anyone can take the Basic Instructor course, there are minimum qualifications you must meet in order to become a certified TCOLE instructor. We only issue the Basic Instructor award if you apply for it and meet the requirements.

# Updating My College Information

You may have noticed that your college information is missing from your TCOLE record, yet you remember giving your transcripts to your department when you first started working there some time ago. Even though collecting information from you about your formal education is part of the hiring process, it doesn't mean your department will use that information to update your TCOLE record. In fact, a lot of departments collect this information for the sole purpose of hiring you. Updating your formal education with TCOLE is your responsibility, as the holder of the license. If you work for a department that has access to our TCLEDDS system, you can check with them to see if they will add your college information to your record for you. They may even still have copies of your transcripts, if you had previously provided them. Otherwise, you can submit the College Education Request (F-7) form found on our website under Forms and Applications at www.tcole.texas.gov.
