

Senate Bill 24, passed by the 87th Texas Legislature, tasks the Texas Commission on Law Enforcement with developing and implementing an electronic process by which agencies can share licensees' employment files for background investigation purposes.

For all licensee appointments on or after January 1, a Law Enforcement agency representative who is working on the pre-employment background phase of an appointment must submit the Background Confirmation Form (BCF) available on the TCOLE website. A copy of the BCF should be retained by the hiring agency along with the F-5R in the appointee's TCOLE file. A copy must also be provided to TCOLE via email at <a href="mailto:secureshare@tcole.texas.gov">secureshare@tcole.texas.gov</a>.

Education Services was tasked with creating the telecommunicator CPR course following the passage of H.B. 786 by the 87th regular legislative session. The instructor resource guide for "Cardiac Emergency Communication" is published on the TCOLE website. Education Services is also in the early phases of creating the e-learning course for Cardiac Emergency Communication.

Updates have been made to the BPOC 720 curriculum in the Code of Criminal Procedure, Alcoholic Beverage Code, Victims of Crime, and Transportation Code/Crash Investigations. Please visit the TCOLE website for the updated curriculum. The curriculum <u>can</u> be used now, but <u>must</u> be implemented for BPOCs starting on or after July 1st.

The Education Services team is currently working on the Mental Health Officer course update. The course will be open for public comment by mid-March 2022 and will be published in April 2022.

## Public Safety Report System (PSRS)

The Office of Court Administration, in partnership with Automon, has started collecting information from future users of the PSRS so that the administrative accounts can be created. Training for the system will begin in March and will be provided by Automon.

To address many of the questions received related to the Public Safety Report System (PSRS) OCA will be hosting weekly Q&A sessions until the PSRS launch date of April 1st.

## **Proposed Rule Changes**



Rules proposed for amendment during the September 2021 meeting are currently open for public comment. Please send your feedback to public comment@tcole.texas.gov.

The following proposed rule changes will be taken up for adoption during the April 14th Commission meeting:

- §211.27 Reporting Responsibilities of Individuals. Updates language related to military discharges for consistency.
- §211.30 Chief Administrator Responsibilities for Class A and B Waivers. Allows for waivers to be transferred with TCOLE staff approval.
- §217.1 Minimum Standards for Enrollment and Initial Licensure. Updates requirements for background investigations in response to the passage of Senate Bill 24 (87R).
- §218.3 Legislatively Required Continuing Education for Licensees. Adds CPR training to continuing education requirements for telecommunicators in response to the passage of House Bill 786 (87R).
- §219.1 Eligibility to Take State Examinations. Changes the issuance of a license to be upon passage of the state exam rather than upon first appointment, with a license going inactive absent an appointment in two years.
- §219.11 Reactivation of a License. Sets forth the reactivation process for those who do not receive an appointment within two years of licensure.
- §221.31 Retired Peace Officer and Federal Law Enforcement Officer Firearms Proficiency. Repeals the firearms proficiency rule in response to the passage of Senate Bill 198, which places this process in statute.
- <u>§223.19 License Reactivation</u>. Updates language related to military discharges for consistency.
- §227.7 School Marshal Renewals. Standardizes the expiration of school marshal licenses in response to the passage of Senate Bill 785 (87R).



Concerns have been raised about the potential misuse of new drone technology and it has been noted that lawmakers should consider what their potential law enforcement uses should be. With the increased use of drones both by civilians and government agencies, it's essential for your law enforcement agency to form effective department drone policies.

House Bill 1758, passed by the 87th Texas Legislature, amends the Code of Criminal Procedure and Penal Code to require each law enforcement agency that uses or intends to use a drone for law enforcement purposes to adopt and update as necessary a written policy regarding the agency's use of force by means of a drone and to submit the policy to the Texas Commission on Law Enforcement every two years. The bill also limits the circumstances under which the use of force, including deadly force, involving a drone is justified. The bill went into effect on September 1, 2021. An agency would have to submit the policy to the Texas Commission on Law Enforcement (TCOLE) by January 1 of each even-numbered year.

So, what exactly is considered a "drone"?

The bill defines a "drone" as an unmanned aircraft, watercraft, or ground vehicle or a robotic device that is controlled remotely by a human operator or operates autonomously through computer software or other programming.

Under the bill, the use of force, including deadly force, involving a drone would be justified only if:

the actor was employed by a law enforcement agency;

the use of force would have been justified under other state law and did not involve the use of deadly force by means of an autonomous drone;

and before the use of force occurred, the law enforcement agency employing the actor adopted and submitted a policy to TCOLE as required by the bill and the use of force conformed to the policy.



#### **AUTHOR'S / SPONSOR'S STATEMENT OF INTENT**

Drone technology presents an innovative approach to policing, and many departments across the state have begun implementing this technology as a matter of policy. The advent of weaponized and autonomous drones is accompanied by a litany of concerns regarding the ethics of policing through drones.


The legislation recognizes the necessary human element of policing and prohibits the use of deadly force by means of a fully autonomous drone. H.B. 1758 will allow the legislature to take account of the state's various drone policing policies, thus giving policymakers an accurate depiction of how drones are used from one law enforcement jurisdiction to the next.
