Monday, May 30<sup>th</sup> was the final day of the 82<sup>nd</sup> Regular Session of the Texas Legislature. As of Friday the 27<sup>th</sup>, the law-enforcement-related bills listed below had been approved by both chambers and sent to the governor's office. Over the coming weeks, many of them will probably be signed into law, along with other bills that were either approved in the last days of the regular session or re-examined in the special session. ## Save Time - Do A Background Investigation

#### From the Executive Director

Ever hear the story about a man who figured out how many Saturdays were in his future if he lived to his statistical life expectancy? He multiplied the number of years by 52 and purchased that number of marbles. He placed them in a large, transparent jar in his garage, and every Saturday he made it a ritual to remove one. This jar, with fewer and fewer marbles, became a weekly reminder to him of his mortality. Those Saturdays became reality checks and, as the story goes, he remembered to live life to its fullest and not waste time. This reality check helped him cherish his family and friendships more, and he stopped putting off telling people how much he appreciated them and their enduring friendships. This story is a real lesson in time management.

Time management has many universally proven principles and many personal techniques that each of us develop throughout our lifetime.

One time saver that I strongly subscribe to is the time an agency can save by doing a thorough and complete background investigation of potential employees. I have come to realize that for every hour spent on a thorough and complete background, many hundreds and even thousands of hours are saved by knowing past successes and past failures of applicants. I have ignored some telltale signs that cost me and my agency many hours because my hope for change that just didn't occur.

There are a few axioms that reinforce the concept of thorough background checks. One axiom is "the best predictor of future behavior is past behavior." Another is, "people change, but seldom." A thorough and complete background check is essential in law enforcement. Without it, you are ignoring the best predictor of future behavior. You wouldn't go into a darkened building without a flashlight, so why do some chief administrators hire someone to enforce the law without a thorough and complete background investigation?

As you move forward in your careers, remember your personal life and employment history follow you, and you will have to defend it in almost every future interview.

As Smith Barney would say, "you got it the old fashioned way: you earned it." You earned your life and work history, and it is now your reputation. As you remove that marble every Saturday, can you be proud, or do you suffer with irreversible regret?
