221.27 To qualify, an applicant for an instructor proficiency certificate must meet all proficiency requirements, and must have:

(1) substantial experience in teaching or in the special field or subject area to be taught, to include:

(A) two years' experience as a peace officer, telecommunicator, or jailer; or

(B) a bachelor's degree and two years of teaching experience; or

(C) a graduate degree; and

(2) successfully completed an instructor training course or its equivalent, as determined by the executive director.

Equivalents: TEEX Methods of Instruction, TX Dept. of Health Instructor, TX Fire Commission Instructor, FBI Instructor Development Course, US Air Force Basic Instructor Course, US Air Force Academic Course, US Army Total Army Instructor Course (131-ITC-1-L1), US Army Common Faculty Development Instructor Course (CFD-IC), US DOE/NNSI Basic Instructor Training, Defense Information School-Instructor Training Course, Secret Service Instructor Course, 3950 DARE Course **plus** 3951 DARE Instructor Course NHTSA EMS Educators Instructor Course, or Other State POST Instructor Course.
