The City of Bastrop Police Department is a cohesive, collaborative team of professionals dedicated to providing our community exceptional public service and possess a willingness and compassion to work together with the citizens of Bastrop to maintain a healthy and safe community. The Department has a full-time staff of 31 sworn police officers, and 6 civilian support staff. If you are driven by a desire to contribute, possess a willingness to be challenged, committed to public service, and want to be a part of an exceptional team that makes a difference in the everyday life of the Citizens of Bastrop, come join our team as a Detective. Under the direct of a Criminal Investigations Sergeant, CI Lieutenant, and/or the Chief of Police, a detective is responsible for performing law enforcement and crime prevention duties; and conducting criminal investigations. Performs related duties as required. Essential functions, as defined under the Americans with Disabilities Act, may include any of the following representative duties, knowledge, and skills. This is not a comprehensive listing of all functions and duties performed by incumbents of this class; employees may be assigned duties which are not listed below; reasonable accommodations will be made as required. Essential duties and responsibilities may include, but are not limited to, the following:

- Performs complete preliminary and follow-up investigations of crimes and crime scenes either independently or as a member of a team. Prepares case files, reports, and evidence for submittal to the Bastrop County District Attorney's office or City Attorney. Interviews witnesses, victims, suspects, arrested persons, complainants and informants; takes depositions and/or statements. Writes arrest and search warrants.
- Adheres to assigned work schedule as outlined in the Department and City's attendance policies and procedures; ensures all behaviors comply with the City's Personnel Policies Manual.
- Performs other related duties as required.

Salary is DOQ - entry level is \$33.07 per hour prior to any stipends
