In order to become a Childress Police Officer, you must meet the following minimum requirements.

- ➤ Be a citizen of the United States;
- > Possess a valid Texas Driver's License;
- ➤ Must be a minimum of 21 years of age at the time of Appointment;
- Must possess a Texas Peace Officer License or eligible to attend the Basic Peace Officer Academy;
- Possess High School Diploma or Equivalent
- Military veterans will not be considered with a DISHONORABLE DISCHARGE documented by a DD-214;
- Must pass a medical and psychological evaluation.



## **Required Documents**

Applicants will receive a Personal History Statement (PHS) to complete and return to the Chief of Police or Designated Background Investigator. You will be required to provide the documents listed below. Applicants should, at this time, begin to collect these documents as failure to return the completed PHS and required documents will not be considered for employment.

- > Copy of your Social Security card.
- Original certified copy (or photocopy if authenticated by agency designee) of your birth certificate.
- > Copy of your valid Texas driver license
- Copy of your High School diploma or GED certificate.
- ➤ Sealed original certified copy of your college transcript. (No photo copy)
- Photocopy of your college diploma.
- Copy of your Texas peace officer license
- Copy of your DD-214 if applicable.Must possess an honorable discharge.
- ➤ Original certified copy of your Naturalization papers, if applicable. (No photo copy)
- > Copy of current proof of automobile liability insurance.
