# TEXAS COMMISSION ON LAW ENFORCEMENT

## Quarterly Meeting Minutes June 11, 2015

On Thursday, June 11, 2015, at 9:30 a.m., the quarterly meeting of the Texas Commission on Law Enforcement (TCOLE) met. The meeting was held at the J.J. Pickle Research Campus, The Commons Learning Center, 10100 Burnet Road, Bldg 137, Austin, Texas.

Commissioners attending were Sheriff Joel W. Richardson, Presiding Officer; Ms. Patt Scheckel-Hollingsworth, Assistant Presiding Officer; Major Jason Hester, Secretary; Ms. Patricia Garza; Constable Ron Hood; Mr. Rob Kyker; Mr. James Oakley; Senior Police Officer Joe Pennington; and Chief Ruben Villescas.

### **Agenda item #1, Call to order**

Presiding Officer Richardson called the meeting to order. Robert Jackson, Michael Black, Jessica Varela, Richard Perez, Rick Hauck, and Gabriel Macias of the Texas Department of Public Safety Color Guard presented the colors. Commissioner Kyker led the pledge of allegiance, and Commissioner Hester gave the invocation. Kaye Wilson called the roll and announced that all commissioner were present.

### **Agenda item #2, Reading of peace officer/jailer deaths since the March 2015 meeting.**

Ken Mobley announced that there have been two deaths since the March 2015 meeting.

**Agenda item #3, Approval of the minutes of the March 5, 2015, quarterly commission meeting at Austin, Texas.**

Commissioner Hester made a motion to adopt the minutes. Commissioner Oakley seconded the motion. The motion passed unanimously.

**Agenda item #4, Receive Presiding Officer's Report. Take action, if necessary.**

No action taken.

**Agenda item #5, Receive Executive Director's Report. Take action, if necessary.**

Executive Director Vickers reminded everyone that the 2014 Law Enforcement Achievement Awards ceremony will take place June 12. Nominations are now open for the 2015 awards.

After 26 years of dedicated service, Laura LeBlanc retired from TCOLE, and Chris Varady is now the agency's Public Information Officer. Nikki Johnson will handle the School Marshal program, and Michele White is the agency's full-time receptionist.

The budget for the upcoming biennium includes 10 new full time employees, increasing the agency's enforcement and field services capabilities.

Credit will be awarded to TCOLE licensees that attend the quarterly meetings. A roster will be available for signing at the conclusion of the meeting.

Peace officer standards and training directors from around the United States and from 13 countries attended the International Association of Directors of Law Enforcement Standards and Training (IADLEST) conference hosted by the state of Texas. A new level of membership is now available for training coordinators and academy directors. The National Certification Program is a new initiative being undertaken by IADLEST. Mr. Vickers explained the program, and additional information is available on the IADLEST website.

Commissioner Hester made a motion to accept the Executive Director's report and Commissioner Oakley seconded the motion. The motion passed unanimously.

**Agenda item #6, Receive Legislative Report. Take action, if necessary.**

Director Grigsby noted that approximately 1,300 bills passed this legislative session and several of these have a direct impact on TCOLE. These include HB 593, animal encounter training; HB 1338, traumatic brain injury training; HB 2053, child safety check

alert list; HB 2684, child behavior training for school-based law enforcement; SB 158, body camera program; and SB 1987 training on interactions with deaf or hearing impaired drivers.

Executive Director Vickers noted that a committee has been working on the legislative update course, and changes will need to be made to the basic peace officer course to incorporate new legislation.

Commissioner Oakley made a motion to approve the report and Commissioner Hester seconded the motion. The motion passed unanimously.

**Agenda item #7, Receive Operations Report. Take action, if necessary.**

Division Chief Antu opened by reporting on the status of non-compliance notification. The first letters issued to agencies included approximately 16,000 names. This past Monday, a new non-compliance list was run and the numbers are down to 11,000.

Mr. Antu also stated that beginning September the agency will accept training provider contract applications. This two-step process begins with the receipt of the initial application, then the fee collection, followed by an on-site visit. Special consideration will be given to the needs assessment and the benefits to the region. Non-Texas applicants will be required to follow the same process as Texas applicants. The approval process is still in the planning stages. Commissioners Hester and Hollingsworth asked for the agency to re-address the fee schedule concerning commercial providers.

Commissioner Oakley made a motion to approve the Operations report and Commissioner Garza seconded the motion. The motion passed unanimously.

**Agenda item #8, Discuss and take action on Achievement Awards.**

Executive Director Vickers noted that one name had been inadvertently omitted from the list of names that the Commissioners approved at the March meeting. He asked that the Commission vote on the additional name.

Commissioner Oakley made a motion to approve the additional name for the Achievement Award, and Commissioner Hester seconded the motion. The motion passed unanimously.

**Agenda item #9, Discuss and take action on the Request for Waiver of TCOLE Rule 217.1 Minimum Standards for Enrollment and Initial Licensure.**
