TARGET 100 INITIATIVE

TCOLE is prioritizing and targeting a 100% compliance rate as the goal in the current training period ending on August 31, 2025, is to eliminate the number of licensees subject to suspension or revocation.

To carry out our Target 100 Initiative, TCOLE staff is consistently communicating with agencies and their appointed licensees about incomplete or missing training.

To check your status, visit [MyTCOLE](#) and click on **MyCompliance (see steps on page 12)**.

If you are lacking training, you will be able to see what courses and how many hours you still need to become compliant. If you have completed all required training for the unit, your Compliance page will let you know that you are compliant.

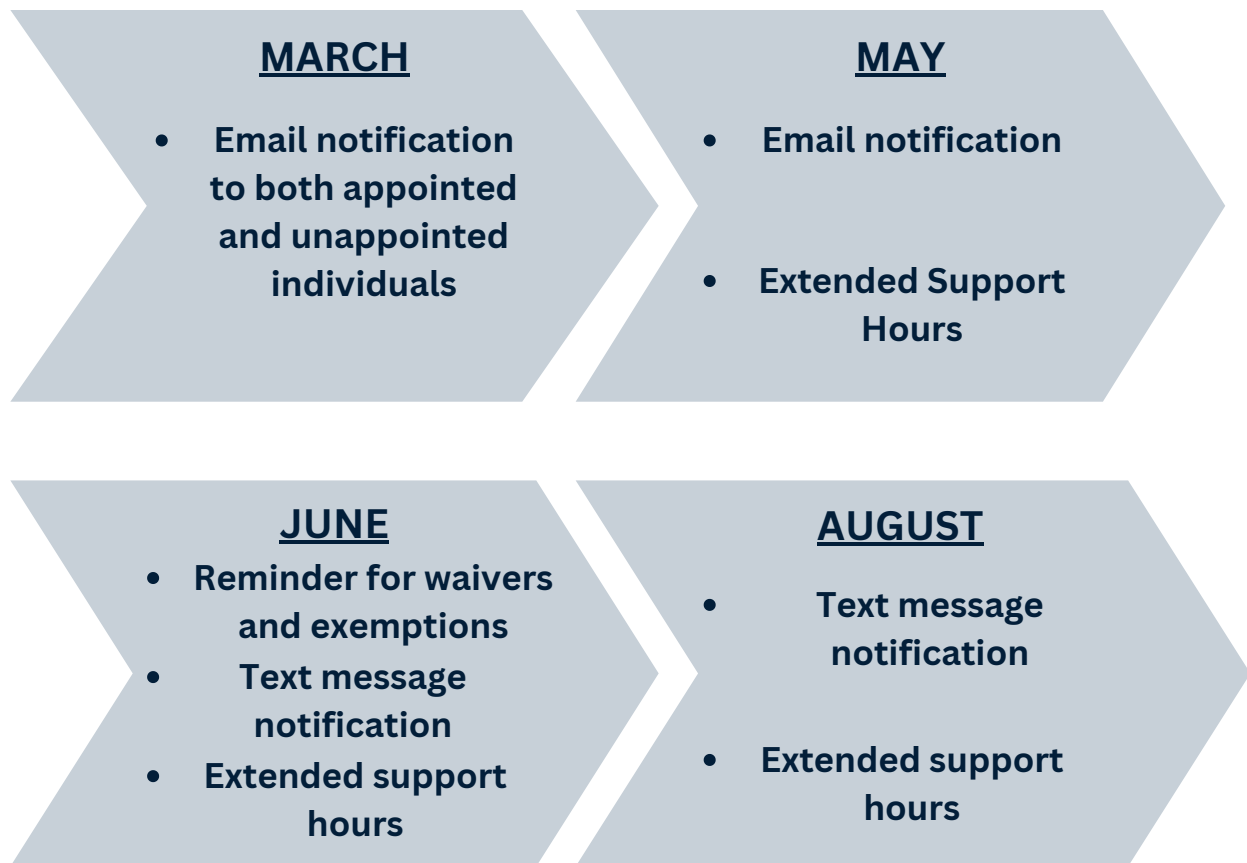

TARGET 100 INITIATIVE

TCOLE works to achieve our Target 100 initiative in several ways including a series of notifications that go out via email and text message to individual license holders leading up to the target date – the end of the training unit and cycle, **August 31, 2025**.

This year, TCOLE will be offering extended support hours from 7 a.m. – 7 p.m. in the weeks that follow notifications. TCOLE will also offer open office hours to training coordinators, managers, and chief administrators who have training requirement questions or questions about how to run the Target 100 report.

Your agency can help us out by asking your licensees to log into their MyTCOLE account (<https://tcledds.tcole.texas.gov/IAM/Identity/Account/Login>) and do the following:

1. Update their contact information so they can receive reminders and notifications from TCOLE
2. Check the My Compliance page for their outstanding training requirements

TCOLE TRAINING REQUIREMENTS

LICENSED PEACE OFFICER

4-year Training Cycle: (9/1/21-8/31/25)

If you do not have an Intermediate Proficiency Certificate or higher, the following will be required for completion:

- Crisis Intervention Training (#3843 or #1850)
- Cultural Diversity (#3939 or #394)
- De-escalation Techniques (#1849)
- Special Investigative Topics (#3232)

2-year Training Unit: (9/1/23-8/31/25):

- Legislative Update course (#3188)
- 16 hours of ALERRT training*
- Finding Wellness – Building a Healthier Life (course #4202) in-person or on MyTCOLE 3.0.
- Trauma-Informed Approach to Sexual Assault Investigations (MyTCOLE 3.0 online course #470 or in-person training course #4070), if not completed in the 9/1/21-8/31/23 unit. An equivalent to this course will be #3264 – Special Investigator Certification.

CONSTABLES

- Newly Elected Constables:
 - Must complete Newly Elected Constable training (#3742 – does not include any ALERRT training hours) thru LEMIT within 2 years of first appointment as Constable.
- Constable Continuing Education:
 - Must complete Continuing Education for Constables (#3743) thru LEMIT each 4-year training cycle thereafter. The course includes 8 hours of ALERRT training. You will be required to complete an additional 8 hours of ALERRT training to meet the 16-hour legislative requirement.
- Civil Process:
 - Must complete Civil Process (#1415) through the Justices of the Peace and Constables of Texas (JPCA) from the Texas Justice Court Training Center (TJCTC) at Texas State University each 4-year training cycle.

TRAINING REQUIREMENTS (CONTINUED)

CHIEF OF POLICE

- New Chief:
 - Must take 80 hours of New Chief's Training:
 - New Chief Development Program (#3780 - does not include any ALERRT training hours) AND
 - Texas Police Chief Leadership Series (#3740)
 - at Bill Blackwood Law Enforcement Management Institute of Texas (LEMIT) within 2 years of first appointment as a Texas Chief of Police.
- Chief's Continuing Education:
 - Must complete the Texas Police Chief Leadership Series (#3740) each unit thereafter. The course includes 8 hours of ALERRT training. You will be required to complete an additional 8 hours of ALERRT training to meet the 16-hour legislative requirement.

COUNTY JAILERS

- Cultural Diversity course (#3939 or #394) every 4-yr training cycle by 08/31/2025. If you have an active Peace Officer license and a Peace Officer Intermediate Proficiency Certificate or higher, you do not need to complete Cultural Diversity.

Telecommunicators:

Current 2-year Training Unit: (09/01/23 - 08/31/25):

- A minimum of 20 hours of training to include Cardiac Emergency Communications (#786)**.

**A current, nationally recognized CPR certification is required in order to enroll.

ALERRT TRAINING

The passage of Senate Bill 1852 requires all peace officers to attend ALERRT Level 1 training at least once prior to 8/31/2027. Courses which will satisfy this requirement include #3311, #3313, and train-the-trainer #3315. This new law also requires that every peace officer complete 16 hours of ALERRT training every two-year unit going forward.

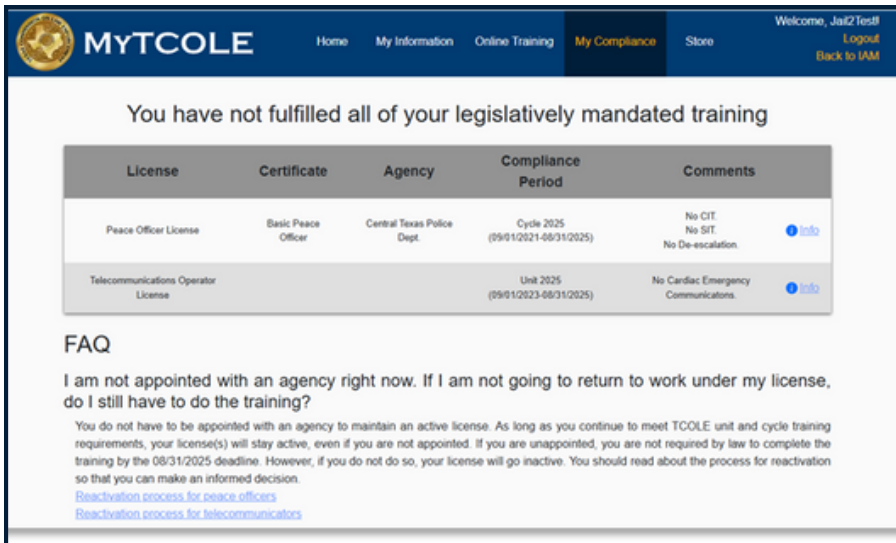


MYTCOLE UPDATES

The MyTCOLE application is getting a more modern look and feel. Behind the scenes, the new application is built using current framework and practices to modernize the technology as well as make future enhancements easier to rollout.



The menu bar in MyTCOLE has been improved, and several features have been reorganized – for example, the printable PSR is now located on the Home page, and the Store features have been re-worked.



Info icon provides information specific to the remaining courses needed. For example:

No CIT:

Indicates that you must complete Crisis Intervention Training (TCOLE 3843 or TCOLE 1850). These courses are only available as in-person classes (no online class). This course is required every four-year training cycle until your peace officer license reaches an Intermediate Proficiency Certificate or higher.

No SIT:

Indicates that you must complete Special Investigative Topics (TCOLE 3232). The course is available through many online training providers and can also be attended in-person. This course is required every four-year training cycle until your peace officer license reaches an Intermediate Proficiency Certificate or higher.

No De-escalation:

Indicates that you must complete De-escalation Techniques (TCOLE 1849). This course is only available as an in-person class (no online class). This course is required every four-year training cycle until your peace officer license reaches an Intermediate

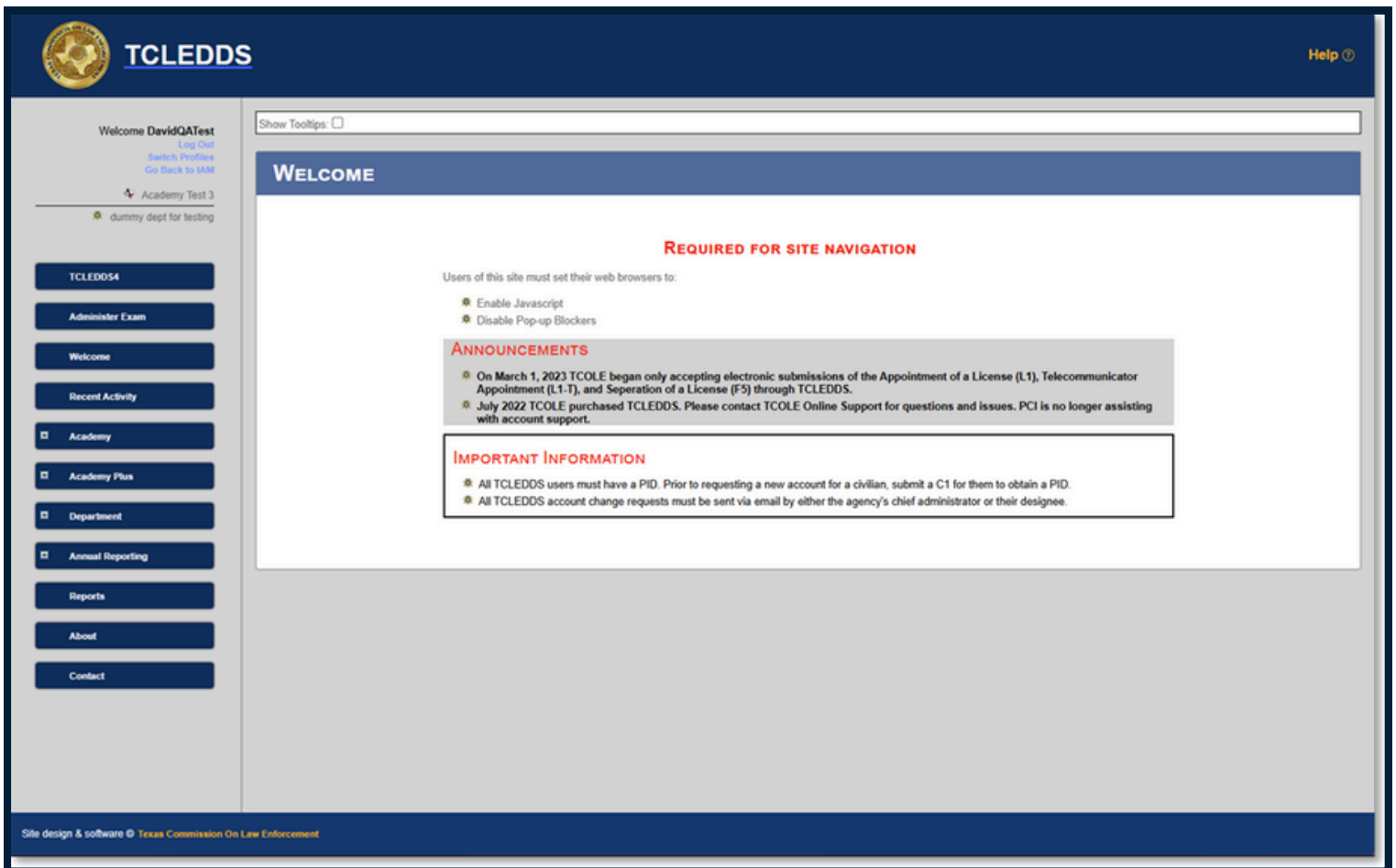

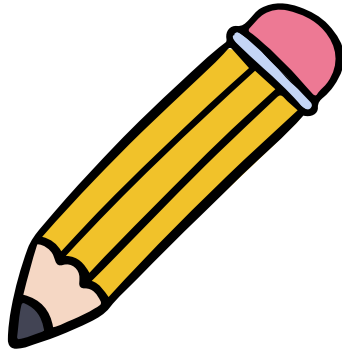

Course Updates

The **Basic Jail Certification Course for Sworn Texas Peace Officers (course #1107)** has been updated. The Basic Jail Certification course for Sworn Texas Peace Officers consists of nine (9) chapters from the Basic County Corrections Course. Please refer to the Basic County Corrections Course curriculum (1120) for student learning objectives and course content. Please go to www.tcole.texas.gov to find the course content. Click on "Training" then "Course Curriculum Materials and Updates." Please note:

- Minimum course hours have been increased to 59 hours.
- Topic on suicide prevention has been added to the curriculum.
- Training coordinators must implement the new curriculum by June 1, 2025.
- Course hours in TCLEDDS will remain at a minimum 32 hours until June 1st.
- Maximum hours in TCLEDDS have been increased to 59 hours in the event training providers implement the new content before June 1st.

The Proctor Manual has been recently updated. Please find the most recent version on our website under "Information & Resources" then "Publications."

The **Crisis Communications course (2120)** has been completely revised. The new course content can be found at www.tcole.texas.gov.

- Training providers must implement the new content by May 1, 2025.

The Crisis Intervention Training – Update (3843) is currently available for online delivery. Online providers may offer the course online to assist with compliance during this training unit. Please be advised, online providers must remove the class from their online portfolio by September 1, 2025.

Continuing Education



ONLINE TRAINING PROVIDERS

If you are someone you know is not appointed at this time, be aware that all training must be completed thru a TCOLE Training Provider. Training Providers have **30 days** to report training to our agency. Once submitted, the training is reported to your record.

Training Providers and Departments reporting training should keep in mind:

- If an individual has been left off a roster or a roster was submitted with an incorrect PID, the training provider is required to submit a roster amendment form to correct the issue.
- Roster amendments must be completed on the prescribed TCOLE form. If needed, the request for the form should be made by the Training Coordinator/Manager to amend.roster@tcole.texas.gov
- Individual licensees are not able to request this form or request that a roster be amended. The information to update a roster must come from the provider where the training was completed.
