POSITION OVERVIEW

The Galveston County Sheriff Office's Traffic Enforcement Unit has proactive law enforcement deputies that are utilized to deter, prevent, and address traffic related offenses and complaints throughout Galveston County. Utilizing Patrol <u>Motorcycles</u>, the Traffic Enforcement Unit responds to and investigates incidents involving traffic violations, traffic hazards, collisions, and vehicular intoxication investigations.

RESPONSIBILITIES

Traffic Enforcement Units are responsible for proactive enforcement to enhance the safety of our local roadways. These responsibilities are accomplished by:

- 1. Timely and effective traffic complaint management.
- 2. Monitoring roadways for impaired; reckless; distracted; dangerous; unlawful driving.
- 3. Monitoring roadways for pedestrian violations and/or welfare concerns.
- 4. Distributing proper enforcement against impaired; reckless; distracted; dangerous; unlawful drivers/passengers and pedestrians.
- **5.** Timely and effective collision investigations.
- **6.** Coordinating traffic control for special events including: parades, funerals, and exigent circumstances.
- 7. Monitoring roadways and assisting with traffic hazard dissemination during critical weather events.
- **8.** Assisting other divisions and agencies with enforcement operations.

PREFERRED KNOWLEDGE AND EXPERIENCE

- 1. Extensive working knowledge of the Texas Transportation Code.
- 2. Experience and in-depth knowledge of impaired driver enforcement.
- 3. Experience and specialized training for collision investigations.
- **4.** Experience and/or training for traffic interdiction.
- 5. Certification as Intoxilizer Operator.
- 6. Basic Peace Officer Motorcycle Operator Certification or able to attend and complete a Basic Peace Officer Motorcycle Operator Certification course.

MINIMUM QUALIFICATIONS

- 1. Minimum of 2 years of Law Enforcement experience.
- 2. Successfully passed (or pass) the Galveston County Sheriff Office Patrol Field Training Program.
- 3. Completion of a Physical Agility Assessment
 - a. 500m Row on Concept 2 Row Machine
 - i. (70% @ Damper Level 5; 1:48 Male / 2:07 Female) Pass or Fail
 - ii. Applicant will be allowed two attempts but must be completed during the same row assessment.
