#### *Law Enforcement:*

- 5. Serve as district liaison to local law enforcement agencies and juvenile authorities.

### Safety:

6. Develop procedures for safe handling and use of firearms.

- 7. Develop training options and improvement plans.
- 8. Recommend policies to improve the department.
- 9. Ensure that department operations are cost-effective.
- 10. Compile, maintain, and file all physical and computerized reports, records and other documents required.

Supervise and evaluate performance of CISD Guardians.
