

The City of San Marcos offers a Lateral Entry Program for eligible certified peace officers.

## **Eligibility Requirements**

Applicants must:

- Be licensed by TCOLE; or be a certified or licensed out of state peace officer and successfully obtain TCOLE licensing (basic peace officer or higher) within 90 days of hire. At the Chief's discretion, a maximum of two (2) 30-day extensions may be granted.
- Have at least 1 year prior work experience as a full-time commissioned peace officer with similar duties in a comparable law enforcement agency; and
- May not be older than 50 years of age on the date of application.

## Guidelines

- The lateral entry program is for pay purposes only and actual work experience in another law enforcement agency will not be considered for promotional eligibility requirements.
- The Chief of Police shall determine eligibility for lateral entry of police applicants. Eligible applicants may be placed up to STEP 9 of the pay schedule

- Longevity pay will be calculated in the same manner as all Police Officers. No credit will be given to completed years of service in other law enforcement agencies.
- Entry-level police officers placed up to STEP 9 of the pay schedule must also complete a new hire probationary period.
- The Chief of Police's determination of whether an applicant meets the criteria of the lateral entry program and placement in the pay structure shall be final and non-appealable to the Civil Service Commission, arbitrator or to any court.
- Entry-level police officers placed up to STEP 9 of the pay schedule must also complete a new hire probationary period.
