Initial Application – as required by 221.33

221.33 To qualify for a standardized field sobriety instructor certificate, an applicant must meet all proficiency requirements including:

- (1) successful completion of the National Highway Transportation Safety Administration (NHTSA) Standardized Field Sobriety Testing Practitioner Course, 2176 or 2067; or the SFST taken with Academy.
- (2) at least three years' experience as a Standardized Field Sobriety Testing practitioner;
- (3) current instructor license or certificate issued by the commission;
- (4) successful completion of the commission approved SFST Instructor Course, 1016 or Drug Recognition Expert (D.R.E.) Instructor Course 1015;

Renewal – Instructor update course has been completed within the last two (2) years as required by 221.33 and is required to instruct the practitioner's course if applicable.

- (5) completion of a SFST Instructor Update Course 2177, NHTSA (A.R.I.D.E.) 2180 or D.R.E. Update course, 2080, 2083;
- (6) demonstrated proficiency in administration of Standardized Field Sobriety Test before a certified SFST instructor or NHTSA representative. This certificate is required to instruct the practitioner's course 2176 or 2067.

I, the applicant, attest that I meet the requirements for issuance of the SFST Instructor Proficiency Certificate 221.33, including Proficiency Certificate Requirements 221.1(b), and have included the non-refundable \$35 fee.
