# TEXAS COMMISSION ON LAW ENFORCEMENT

## Quarterly Meeting Minutes September 8, 2016

On Thursday, September 8, 2016, at 9:30 a.m., the quarterly meeting of the Texas Commission on Law Enforcement (TCOLE) was held at the J.J. Pickle Research Campus, The Commons Learning Center, 10100 Burnet Road, Bldg 137, Austin, Texas.

Commissioners attending were Sheriff Joel W. Richardson, Presiding Officer; Ms. Patt Scheckel-Hollingsworth, Assistant Presiding Officer; Major Jason Hester, Secretary; Ms. Patricia Burruss; Constable Ron Hood; Mr. Rob Kyker, Mr. James Oakley; Senior Police Officer Joe Pennington; and Chief Ruben Villescas.

Raymond Winter of the Office of the Attorney General assisted the commissioners in the absence of General Counsel John Beauchamp. Veena Mohan and John Banaszak represented the Office of the Attorney General. ### **Agenda item #1, Call to order**

Presiding Officer Richardson called the meeting to order at 9:30 a.m. The presentation of colors was by the Randall County Sheriff's Office Honor Guard members Lt. Tommy Bushek, Sgt. Jeff Hooten, Sgt. Raymond Gibbons, Cpl. Cody Weavers, Deputy Jay Claxton, and Deputy Richard Beals. Commissioner Hood led the pledge of allegiance and Commissioner Hester gave the invocation. Roll was called and a quorum was present.

The Presiding Officer introduced special guests Representative John Raney and Chief Robert Moore. Rep. Raney represents House District 14, which is a portion of Brazos County, the College Station area, and serves on the House Appropriations Committee. Chief Moore is the Presiding Officer of the Texas Commission on Fire Protection and

has 20 years with the Texas A&M Engineering Extension Service Emergency Services Training Institute.

Efforts are being made for police, fire, and EMS to work closely in active shooter situations.

**Agenda item #2, Reading of peace officer/jailer deaths since the June 23, 2016, meeting.**

Ken Mobley read the names of eleven line of duty deaths since the last commission meeting.

***Police Officer Calvin "Mark" McCullers, Southern Methodist University Police Department, EOW Tuesday, July 5, 2016***

Police Officer Mark McCullers drowned when his vehicle was washed away in torrential flooding while he was working an off duty assignment at a construction site in Highland Park.

Officer McCullers was a U.S. Marine Corps veteran and had served with the Southern Methodist University Police Department for 17 months. He is survived by his wife and six children.

***Senior Corporal Lorne Bradley Ahrens, Dallas Police Department, EOW Thursday, July 7, 2016***

Corporal Ahrens had served with the Dallas Police Department for 14 years and had previously served with the Los Angeles County, California, Sheriff's Office for 11 years. He is survived by his wife and two children. His wife also serves with the Dallas Police Department.

***Sergeant Michael Joseph Smith, Dallas Police Department, EOW Thursday, July 7, 2016***

Sergeant Smith was a U.S. Army veteran and had served with the Dallas Police Department for 27 years. He is survived by his wife and two daughters.

***Police Officer Michael Leslie Krol, Dallas Police Department, EOW Thursday, July 7, 2016***

Officer Krol had served with the Dallas Police Department for nine years and had previously served with the Wayne County, Michigan, Sheriff's Office for four years.

***Police Officer Patricio E. Zamarripa, Dallas Police Department, EOW Thursday, July 7, 2016***

Officer Zamarripa was a U.S. Navy veteran and had served with the Dallas Police Department for six years. He is survived by his wife, 2-year-old daughter, and stepson.

***Police Officer Brent Alan Thompson, Dallas Area Rapid Transit Police Department, EOW Thursday, July 7, 2016***

Officer Thompson was a U.S. Marine Corps veteran and had served with the Dallas Area Rapid Transit Police Department for nine years. He is survived by his wife, six children, and three grandchildren. His wife also serves as an officer with the DART Police.

Police Officer Patrick Zamarripa, Senior Corporal Lorne Ahrens, Police Officer Michael Krol, Sergeant Michael Smith, of the Dallas Police Department and Police Officer Brent Thompson, of the Dallas Area Rapid Transit Police Department, were shot and killed by an active shooter during a protest in downtown Dallas.

As the protesters walked down Main Street between South Lamar Street and South Market Street, a sniper opened fire on police officers who were providing security for the event. The man shot a total of 12 officers, killing five and wounding seven.

The subject was cornered in an adjacent parking garage and barricaded himself inside for several hours while he spoke to negotiators. He was killed when the Dallas Police Department's Bomb Squad moved an explosive device to the man's location using a robot and detonated it.

***Police Officer Marco Antonio Zarate, Bellaire Police Department, EOW Tuesday, July 12, 2016***

Police Officer Marco Zarate was killed in a motorcycle crash while pursuing a vehicle that had been involved in an earlier shoplifting.

Officer Zarate was a U.S. Marine Corps veteran and had served with the Bellaire Police Department for seven years. He is survived by his wife and three daughters.

**Corrections Officer Mari Johnson, Texas Department of Criminal Justice, EOW  
Saturday, July 16, 2016**

Corrections Officer Mari Johnson was killed by a male inmate inside of the Robertson Unit in Abilene, Texas.

Officer Johnson had served with the Texas Department of Criminal Justice for seven years.

***Police Officer Justin Scherlen, Amarillo Police Department, EOW Thursday, August 4, 2016***

Police Officer Justin Scherlen succumbed to injuries sustained 11 months earlier when his patrol car was struck head-on by another vehicle. He underwent numerous surgeries and continuous rehabilitation following the crash, but died from complications on August 4th, 2016.

Officer Scherlen had served with the Amarillo Police Department for 11 years and was assigned to the Uniformed Division. He also served on the agency's Honor Guard and Dive Team. He is survived by his wife and four children.

***Senior Police Officer Amir Abdul-Khaliq, Austin Police Department, EOW Sunday, September 4, 2016***

Senior Police Officer Amir Abdul-Khaliq succumbed to injuries sustained four days earlier in a police motorcycle crash while providing an escort for a funeral.

Officer Abdul-Khaliq was a U.S. Marine Corps veteran and had served with the Austin Police Department for 17 years. He is survived by his five children.

***Deputy Sheriff Kenneth Hubert Maltby, Eastland County Sheriff's Office, EOW  
Wednesday, September 7, 2016***

Deputy Sheriff Kenneth Maltby was killed in a vehicle crash when his patrol car was struck head-on by another vehicle.

Deputy Maltby had served with the Eastland County Sheriff's Office for two years and had 42 years of law enforcement service.

**Agenda item #3, Approval of the minutes of the June 23, 2016, quarterly commission meeting at Austin, Texas.**

Commissioner Hester made a motion to approve the minutes of the June 23, 2016, meeting. Commissioner Oakley seconded the motion. The motion passed unanimously.

**Agenda item #4, Receive reports. Take action if necessary.**

- Presiding Officer's Report

- Executive Director's Report

The Executive Director referred to an agenda item from the June 23, 2016 meeting where a reprimand was being issued to Constable Beth Villarreal. That agenda item was abated pending further review of the documents. Mr. Vickers noted that after a subsequent investigation and review of information the Constable provided at the previous quarterly meeting, the reprimand has been withdrawn and staff is seeking a suspension of her license. Constable Villarreal has been notified of this action and has the opportunity to go before a SOAH (State Office of Administrative Hearing) hearing.

Mr. Vickers reminded the commissioners of the annual conference at the Omni Hotel in Corpus Christi, October 3 – 6. Commissioners were invited to attend.

Staff changes include the retirement of Donna Soldner Manning after more than 14 years of service, and the hiring of Ashtyn Cain in Legal, Cera Garrett in Credentialing, and Stan Roper in Enforcement.

- Operations Director's Report

Responding to a question asked by Commissioner Hester, Director Helenberg noted that the Enforcement Division is working on approximately 100 active cases, primarily complaints. There are current openings in the Enforcement Division, Special Services, and the Credentialing Division. Next we will then begin the process of hiring additional field agents.

- Government Relations Director's Report

Director Grigsby welcomed Seth Christenson from the Governor's Office and Hannah Bell from Rep. Molly White's office. The agency's Legislative Appropriations Request (LAR) was submitted on August 5, and we will have a budget hearing with the Governor's Office and the Legislative Budget Board (LBB) on September 26. The pre-filing of bills will begin in early November.

Commissioner Kyker made a motion to accept the staff reports. Commissioner Burruss seconded the motion. The motion passed unanimously.

**Agenda item #5, Discussion of and take actions on proceedings for revocation, suspension, and other disciplinary actions.**

Mr. Winter addressed the Commission, reviewing the disciplinary actions.

Chapa, Gabriella                      Jailer                                      Uvalde Sheriff's Office

The Executive Director seeks to cancel the jailer license issued to Gabriella Chapa as her criminal history makes her ineligible for licensure. The Administrative Law Judge (ALJ) recommends that the license be cancelled.

Commissioner Hollingsworth made a motion to accept the ALJ's recommendation to cancel the jailer license of Gabriella Chapa. Commissioner Hester seconded the motion. The motion passed unanimously.

Mitchell, Robert L.                      Peace Officer                                      Jim Wells Co. Constable Pct. 3

The Executive Director seeks a ten year suspension of the peace officer license of Robert L. Mitchell. Mr. Mitchell received a deferred adjudication for Assault Causes Bodily Injury-Married, a Class A misdemeanor involving family violence. The Administrative Law Judge (ALJ) recommends the ten year suspension.

Commissioner Hollingsworth made a motion to accept the ALJ's recommendation to suspend the peace officer's license of Robert L. Mitchell for a period of ten years. Commissioner Hester seconded the motion. The motion passed unanimously.

Moore, Artez J.                      Peace Officer                                      Harris Co. Constable Pct. 1

The Executive Director seeks a ten year suspension of the jailer and peace officer licenses of Artez J. Moore. Mr. Moore was convicted of Impersonating a Peace Officer/Misrepresentation of Property, a Class B misdemeanor, deferred adjudication. The Administrative Law Judge (ALJ) recommends a ten-year suspension of the licenses.

Commissioner Hollingsworth made a motion to adopt the ALJ's recommendation to suspend the peace officer license of Artez J. Moore for a period of 10 years. Commissioner Hester seconded the motion. The motion passed unanimously.

Turner, Bradley L.                      Peace Officer                      Trinity County Sheriff's Office

The Executive Director seeks to cancel the peace officer license issued to Bradley L. Turner as his criminal history makes him ineligible to enroll in peace officer training and be licensed. The Administrative Law Judge (ALJ) recommends cancellation of the peace officer license. Mr. Turner was placed on community supervision in an order of deferred adjudication for Burglary of a Vehicle, a Class A misdemeanor.

Mr. Turner appeared on his own behalf and spoke with the commissioners and asked that they reconsider the cancellation.

The Presiding Officer explained that there is a procedure to follow to obtain a waiver for the Class A misdemeanor. The Executive Director offered to visit with Mr. Turner and explain the procedure.

Commissioner Hollingsworth made a motion to accept the ALJ's recommendation to cancel the peace officer license of Bradley L. Turner. Commissioner Hester seconded the motion. The motion passed unanimously.
